Serving Pierce County citizens in need

Pierce County Dentists Care was established in 2004 by the **Pierce County Dental Foundation** and the **Pierce County Dental Society** to meet the oral health needs of underserved children and adults in the community.

Candidates for the program are identified and referred through school screenings and by local agencies. Participants are then placed with one of many Pierce County dentists who have volunteered to provide emergency care and services.

Monetary donations help offset the costs to run the program.
